Agroprogres represents, warrants and agrees that, in connection with the performance of its duties hereunder, it shall not make any payments, in money or any other item of value or make any offers or promises to pay any money or any other item of value, including, but not limited to, gifts to (a) any government official, (b) any political party, (c) any candidate for political office or (d) any other person or entity, with the knowledge that such payment, offer or promise to pay will be made to any government official for the purpose of influencing such government official to make one or more business decisions favorable to GLOCK, Agroprogres or both.

This Certificate is made and governed under Austrian Law. Vienna, Austria, shall be the venue for all legal disputes arising from or in connection with this Certificate. Agroprogres hereby expressly consents to the personal jurisdiction of an Austrian Court for any dispute arising from or in connection with this Certificate.
